PRMS Hockey Academy students and their parents fundraised \$2,800 for the school lunch program.

The Northern Development Initiative Trust has provided a large grant to support the work of the "Expanding Dual Credit Trades Training (Shoulder Tappers')

Project." \$100,000 will be provided each year over the next 5 years to support this project.

The district will start a teacher mentoring project.

The Superintendent presented a video, "Shed is Lyfe," promoting the shed construction project in the CHSS wood shop.
