**Highlights of April 14, 2020 Board Meeting**  
**Meeting held remotely via Zoom**

### **CHSS Continuity of Learning**

CHSS Principal Sandy Pond described the wide variety of ways the school's teaching staff are delivering lessons to their students, and commended the efforts of her teachers as they completed Term 2 report cards while developing new online lessons plans for their students. Principal Pond also praised the work of the school's support staff by collecting and returning student belongings and other material required for the continuity of learning.

"The Board of Education could not be more proud of all district staff as we seek to respond to the suspension of in-class learning as a result of the COVID-19 pandemic," said Board Chair James Horne. "We continue to hope for the best for all staff, students and families."

### **Remote Board Meetings**

As a result of the ban on public gatherings during the COVID-19 pandemic, the Board of Education has moved to remote Board meetings. While this has been a learning curve for all trustees and staff, the Board is committed to continue to hold public meetings and is currently using the Zoom platform for its meetings. The Board expresses their thanks to the Ministry of Education for purchasing a provincial Zoom license for the K-12 sector.

### **School Calendar**

The 2020-2021 and 2021-2022 school calendars with two week Spring Breaks were approved by the Board of Education at their meeting on April 14, 2020 following a spirited debate. Copies of the calendars are attached to this press release.

### **COVID-19 Updates**

The Superintendent of Schools provided an update on the district's responses to the COVID-19 pandemic that has led to the suspension of in-class instruction. There are a multitude of activities underway to address the continuity of learning, food security and the care of children of Essential Service Workers. Support is

## **Capital Budget Approval**

The Capital Bylaw for the 2020-2021 Five Year Capital Plan was approved by the Board of Education. Top of the Board's list is the submission of the Concept Plan for the seismic replacement of Prince Rupert Middle School.

Also approved in this year's capital plan are the following projects:

- Lighting upgrades in all schools;
- Washroom upgrades in all schools (this is expected to be complete over 3 years); and
- Playground equipment at Lax Kxeen Elementary School.

The third and final meeting for the Annual Budget Consultation for the 2020-2021 Annual Budget has been rescheduled to Monday, April 27, 2020 at 7:00 p.m. This meeting will be held remotely via Zoom.
