The Director of Instruction reported 96% of students returning to classrooms, compared to the Provincial average of 85%. 31 students are being home schooled. 29 students are in the Connect program, with 3 teachers supporting them. Schools are still working to bring the last 2% of students back into the classroom.

# 6.1.3 Implementation Day

The Superintendent described the workshops presented by Lleyton Schnellert on September 28, the district's Implementation Day, with a theme of "Inclusive Approaches to Teaching that Nurture Learning". Half-day workshops were provided to Grade 4-8 teachers, and Grade 9-12 teachers. These approaches can improve student attachment to their schools.

K-3 teachers had presentations on literacy, numeracy and Indigenous Education.
